Endeavour Energy Public Lighting Price List

This price list shows Endeavour Energy's charges for the construction and maintenance of Public Lighting Infrastructure.

Public Lighting Services

From 1 July 2009 Endeavour Energy provides Public Lighting under Tariff Classes which align with the Australian Energy Regulator's (AER's) Network Determination as shown in the table below:

Assets constructed* after 30 June 2009		
3	Capital funded by DNSP	Annual efficient maintenance charge (same as those for tariff class 2). Annual capital charge (return of and on) based on efficient material and installation costs.
4	Capital not funded by DNSP	Annual efficient maintenance charge (same as those for tariff class 2). DNSP not entitled to a return on or of capital.
5	Capital funded by the DNSP but asset replaced at the request of the customer before the end of its economic life.	Tariff calculated by the DNSP at the time of agreement to replace the asset early using an agreed method for determining the residual capital value of the asset. The charge is to be paid up front. Residual asset charge calculated for replaced asset based on remaining life determined through an assessment of the assets condition and/or type or the AER default value.

In addition, Endeavour Energy offers a number of unregulated rates for maintenance of public lighting assets owned by customers.

Legacy Rates – Tariff Class 1 & 2

Assets constructed* up to (and including) 30 June 2009 will be charged in the same manner as the previous determination period, adjusted in accordance with the AER's determination. Adjustments have been made for both inflation and redistribution of the existing asset base across the asset classes in a way which more closely reflects the age of each asset class.

These rates are a continuation of rates previously listed under **Schedule 1 & 2** and will no longer be available for assets constructed* from 1 July 2009.

*Constructed is defined by the AER as the date on which a customer accepts a quotation for the construction of new assets.

Annuity Rates – Tariff Class 3 & 4

Applies to assets constructed* on or after 1 July 2009 and are cost reflective rates, recovered over the life of the asset.

Residual Capital Value – Tariff Class 5

Applies where Endeavour Energy has funded the capital, but the asset is replaced at the request of the customer before the end of its economic life.

Using the AER's approved method, the charge is calculated at the time of agreement using the replaced asset's **weighted average remaining life**. The charge is paid at the time of replacement.

Tariff Class 6 - Regulated Tariff Class 4 Maintenance Only

In addition to the five tariff classes detailed above, these tariffs will apply where customers request limited maintenance only services to non-standard public lighting assets that they own and are responsible for.

These rates were previously listed under Schedule 3.

Pricing Methodology

The pricing is consistent with the AER determination on Endeavour Energy's submission on public lighting tariffs to the AER and applies to the next five financial years starting from July 2019 until the end of June 2024.

Tariff Class 1 & 2

The AER have determined that Tariff Class 1 & 2 will be the 2009 closing asset base for public lighting consistent with the roll forward methodology accepted by IPART in its 2008 public lighting decision.

Tariff Class 3 & 4

The AER have determined that Tariff Class 3 & 4 will be an annuity calculation based on the efficient maintenance and capital (Tariff Class 3 only) costs. Capital costs are recovered over the life of the individual assets.

Tariff Class 5

The Residual Asset Charge is calculated for the replaced asset based on its **weighted average remaining life**.

Terms and Conditions

The attached price schedules show the Public Lighting prices that apply from **1 July 2022**.
